DISCUSSION ITEMS AND MOTIONS:

Bill Demers spoke to the board regarding his concerns of the vehicles parked in the breakdown lane stemming from the full parking at Appalachia Trail parking lot. With all the recent snow fall the banks on the sides of the road are at its limit and there is an RSA stating no parking on the pavement of state highways, there is no room and vehicles are parking in the breakdown lane. Bill also reminded the board of the recent tragedy in that area.

Linda Dupont stated that Bill had come into the town hall that morning and she called NH DOT District 1 in Lancaster. She spoke to Rob Glover and expressed the concerns of the residents. Michele Cormier stated that letters had been written regarding the parking on the North side as well as the south side of US Route 2 in that area, with suggestions of placing signs. Michele will draft and send a letter to NH DOT regarding Bill's concerns.

Bill also suggested to the board to place game cameras in the area of the highway garage. There are cameras that work very well with a little cost to the town.

Joseph and Kelly Eggleston submitted a Demolition Permit to remove the lower garage at Map U6 Lot 6 and a Building Permit to replace the garage expanding it by 6 feet in width.

The board reviewed and approved the Demolition Permit 01-19.

Due to the limitations of the board to follow the Town of Randolph Land Use Policies, they are unable to approved the Building Permit 02-19 for the garage, as setbacks from the road are not met.

The board reviewed a list of land owners subject to upcoming tax liens, Anne Kenison, tax collector, provided to the board.

Michele Cormier reviewed some items discussed at the Hazard Mitigation Update Meeting.

- 1. Have the Town of Randolph obtain membership with Public Works Mutual Aid at a cost of \$25.
- 2. The installation of lightning rods on town buildings.
- 3. Provide information to residents regarding the NHready.com Code Red system.
- 4. Placing an Emergency Management link on the town's website.
