DISCUSSION ITEMS AND MOTIONS:

Chuck Lowe came before the Board of Selectmen in response to the notification letter he received regarding an Article placed on the Warrant to discontinue completely the West End of Durand Road. Mr. Lowe stated his concerns regarding the liability of injuries that may occur as a result of the town abandoning this section and who would be responsible. Michele Cormier stated this is something we would need to look into prior to Town Meeting.

Melissa Elander introduced Emily Roscoe to the board. Emily Roscoe is a Clean Energy advisor specializing in residential needs. She announced that a meeting will be held at the Gorham Town Hall and it is open to Randolph Residents as well. This will be March 24th at 6 pm at the Gorham Town Hall. Emily will provide information to distribute to interested residents.

Melissa Elander reviewed the energy audit performed by an Eversource Auditor. The recommendation of additional insulation of the town hall was not considered as it would change the Historical appearance of the Cross Meeting room. The board asked about the Municipal Building and the change of the lighting in the bays where the engines are stored. Melissa explained that the program we have considered would need at a minimum of 20 hours a week of usage and this would not apply, but there are other energy grants that may apply and she would direct the information to us.

Edith Tucker appeared as a reporter for the Daily Sun and questioned the board regarding the Pilt agreement with the Town of Gorham. The board just received communication and recommendations from the town’s attorney regarding this agreement. After the board reviewed the recommendations, and discussed the needed changes, Michele Cormier moved to except the agreement with the changes. John Turner seconded with the revisions. All agreed and the agreement was signed with the changes.

The board discussed the importance of having residents contribute and attend the update of the Town of Randolph Emergency Operations Plan. Tentative dates have been scheduled beginning in March.

The next meeting to discuss the reconstruction of Durand Road with Erin Darrow will be held in March. The board is trying for March 24th. Linda will try to see if this date will be accommodating for all.
