DISCUSSION ITEMS AND MOTIONS:

Michele Cormier nominated Bill Arnold as a Cemetery Trustee to fill the vacancy left by Steve Hartman. John Turner seconded the nomination. All agreed. Bill Arnold being present accepted the nomination.
