The committee met on April 26 and plan on meeting with Solar Companies regarding possible sites that solar panels can be placed. They are reviewing energy saving strategies in town buildings. They also plan on scheduling a public meeting this summer, to include summer residents.

The board reviewed and approved an All-Veterans Tax Credit and an annual submission of a PA-48 Farm Structures & Land Under Farm Structures Assessment.

Durand Road: Paul Jadis drew up a letter to be sent to Sharon Penney regarding a turn-a-round location at the east end of Durand Road. Michele Cormier received correspondence from Edith Tucker and the Cutter Family requesting information prior to the public meeting in June.

North Country Council: Michele Cormier attended a meeting focusing on grants. There are grants available for the Scenic By-ways that could possibly be used for sanitary waste stations at the Appalachia Trail Parking on US Route 2.

Michele Cormier informed the board of an application available to request the dangerous Randolph Hill Road intersection to US Route 2 to be addressed in the NH-DOT ten-year plan. She has reviewed the file of letters from residents and the latest accident; damaging the Grand View Cabins sign. This information will be included with the application.

The Town of Gorham has sent another letter regarding a new five-year PILoT contract. Michele Cormier will draft a response to include the 2021 payment that has not been received.

Paul Jadis updated the board on the progress of the Town's website. He will be contacting our existing web master and sign the contract with the new webmaster. Paul is also speaking with Jesse Daniels, who will be taking over the town's mowing needs.

Kevin Rousseau reported to the board, a tree had blown over on Valley Road last week. He noticed the tree in the road while plowing and moved it out of the road. A resident had called complaining that the tree was not removed. Valley Road being a State-owned Road is the responsibility of the NH DOT, the town is responsible for plowing only. Also, a resident on Durand Road had cut trees close to the road and left the fallen tree and brush in the ditch line close to the road. Letters will be sent to the resident on Valley Road and Durand Road.

Paul Jadis discovered a fraudulent site offering on-line payments to the Town of Randolph. Notice was posted on the Town's Facebook Page and in the Monthly Blizzard. Michele Cormier moved to have Anne Kenison, Tax Collector, place an insert with the first Tax Billings notifying residents of the fraudulent site. Paul Jadis seconded. All agreed.
