DISCUSSION ITEMS AND MOTIONS:

The town received a driveway permit for a lot on Cote Acres Road. The board reviewed and approved the permit with the stipulation that a deed is filed with the Coos County Registry of Deeds proving ownership of the property.

Bill Arnold inquired with the Board of Selectmen about several road signs disappearing in town. He inquired as to whom he should report the incident to and if the town was prepared to replace the missing signs. Several of the signs were supplied by Granite Back County Alliance through the Forest Commission and should be addressed at the Forest Commission meeting.

The Westbound sign on US Route 2, asking truckers not to use engine breaks has been removed and will need to be replaced.

Bill also stated the e-911 house markers should not face the incoming entrance to the houses on the roads but to face outwards so that Emergency Responders living on the road can identify the house by number in either direction. The board stated that the numbers are placed to assist the Fire Department and EMTs coming from the main road to assist in a quick response.

Bill also inquired about the status of the Police Committee and if a determination of the surveys sent had been determined. The committee consisting of David Ruble, Bob Harris, Regina Ferrera, and Paul Cormier has not set up a public meeting and the board can address this with the Chair David Ruble.

Kevin Rousseau is still the 1st responder for Randolph. The same procedures are in place. Dial 911 to get Gorham Dispatch, they will contact Kevin Rousseau, and if he cannot respond the State Police will be called.

June Hammond Rowan reviewed Planning Board Fees according to NH RSA 676:4-1G to set reasonable fees prior to submitting an application to the board or committee. This should include Certified letters, Newspaper Ads, and any additional fees. This will be addressed with the Board of Adjustment and the Planning Board for further action.

Bill Demers thanked June Hammond Rowan for her expertise and volunteering in Randolph to help when needed.
