June Hammond Rowan attended the North Country (TAC) Transportation Advisory Committee meeting. She stated the Randolph Project was still in the standings for the next ten-year plan. The determination was between the Town of Albany and Randolph. Although the population of Albany is greater, the speed limit of US Route 2 in the areas of Randolph Hill Road and Raycrest Drive placed Randolph before Albany. It's a two-year process to get into the plan and Randolph will be included in the ten-year plan.

June Hammond Rowan also noted that the paint and pavement on the center lines on US Route 2, has been clumping and chipped away, causing hazardeous conditions on US Route 2.

June Hammond Rowan noted that the Randolph Foundation has grant monies that may help fund the repeater project. Coos County has contributed monies toward the Repeater Project bring down the requested contribution from Randolph to \$6500.00. June recommended asking the Randolph Foundation for these funds. Paul Jadis stated that if June wishes to request the funds from the Randolph Foundation, that she would have the board's blessing. The board is fixed on the original requested which did not ask the town for additional finds. Paul Jadis stated in the beginning when approached the board asked for clarification including line items for requested work. This has since changed and Gorham is now requesting funds from Randolph to complete the project.

Howie Wemyss came before the board requesting the town join Clean Energy of New Hampshire at \$300 a year. They are proactive in obtaining information regarding clean energy,

they lobby for bills to pass regarding clean energy and give their expertise in helping to obtain grants. Paul Jadis stated the board will revisit the request.

Bill Demers requested to be considered in purchasing the old emergency generator no longer in use at the Town Hall. Bill will remove the old generator to make room for the new generator that is on order.

Rick Fournier stated that Paul Kenision has been busy keeping up with the roads, plowing and sanding as needed.
